(*) For goods and transport elements with loading and/or discharging in a Short Sea Shipping regular service, the correcting coefficient will not be applied to goods and elements of transport (disembarking) that had been in maritime transit in the last port and/or (embarking) that are going to be in maritime transit in the first port to be disembarked

To goods and elements of transport, embarkations or disembarkations, entering or exiting the port service area by RAILROAD, a coefficient of 0,50 will be applied

Goods and elements of transport on **TRANSHIPMENT** the tax final amount will be:

1st Among docked ships, 50% of the amount stated, considering that the transshipment equates a disembarking operation.

2nd Ship to ship` transshipment, being docked or anchored, 30% of the amount stated, considering that the transshipment equates a disembarking operation.

Goods and elements of transport in maritime **INNER TRAFFIC** operations, the tax final amount will be applied only once in the embarking or disembarking operation. If the operation is held between facilities under concession or authorization: 50%.

Goods and elements of transport in **LAND TRANSIT** operations, a 50% will be applied to the tax of goods and elements of transport entering the port service area. If the final destination is facility under concession or authorization, it will be applied 40% of the previous amount.
